SECTION 4 - FIRST AID MEASURES

4.1 Description of first aid measures

Inhalation: If product mist or vapor causes respiratory irritation or distress, move the exposed person to fresh air immediately. Ingestion: Rinse mouth thoroughly with water if the victim is conscious. Remove dentures, if present. Do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. O btain medical attention immediately.

4.2 Most important symptoms and effects, both acute and delayed

Potential health symptoms and effects

Eyes: May cause mild, transient irritation with redness and minor discomfort.

Skin: May cause skin irritation. Low hazard for normal industrial handling.

Inhalation: May cause irritation of the respiratory tract.

Ingestion: May cause digestive upset with nausea, vomiting and diarrhea.

SECTION 5 - FIRE FIGHTING MEASURES

5.1 Extinguishable media

5.2 Special hazards arising from the substance or mixture

5.3 Advice for firefighters

Full protective equipment including self-contained breathing apparatus should be used. 7.1 Precautions for safe handling
